After that date, a **late-entry fee of \$10** is applicable, which must be received no later than **October 13, 2008** to be considered. Avoid disappointment – REGISTER EARLY and join us at “Celebrate Samhain”.

Please note that submission of an application does not guarantee acceptance. Submissions are regarded as a request to vend. All submissions will be considered by the organizers of the event for the appropriateness of wares and/or services with regard to the theme of the event, as well as the number of like vendors participating. Vendor spaces are limited, and will be assigned on a first come/first serve basis with the aforementioned considerations applied. If an application is not accepted for any reason, the vendor fee will be promptly returned. Once an application to vend has been accepted, the fee is **NON-REFUNDABLE**.

After this date, the fee will be \$50.00 (per table/space). Payments written against insufficient funds will incur a \$15 bank processing fee upon resubmission.
